This Privacy & Security Statement is not intended to and does not imply any contractual or other legal rights or remedies to or from EHS, its affiliates, subsidiaries, assigns, agents or any other party.

### Security Features

Secure connections are supported on the current server supporting the [www.myhealthpoint.com](http://www.myhealthpoint.com) Web site. Members are urged to review the privacy/security statements of any links that members may access from this site, as such terms may be different and are not the legal responsibility of EHS, as more fully described in the disclaimer language that will be displayed for users prior to entering these links.

### Collection of Personal Information

Entra Health Systems will not be tracking personal data. The only data recorded will be the volume of visits as tracked by IP address and pages accessed. Further, EHS's server, used to support this site, does not place "cookies" on the hard drives of members.

### Use of Data Collected from Input Forms

The current site does have the ability to input personal information onto data input forms. Data must be entered by member to verify identity and authority of user and that information will include, but is not limited to, member name, date of birth, demographic information, insurance information, emergency contact information, exercise and diet and medication related information.

### Disclosure of Data

Entra Health Systems will not sell, trade, or disclose data for any purpose other than EHS's operations.

### Logging and Tracking

Entra Health Systems will be collecting certain activity on the MyHealthPoint Patient Analytics Portal, including, but not limited to, successful and failed log - in attempts as well as usage statistics for all functional components.

### Collection of Personal Data from Children

Children under the age of 18 can access our site only when initiated by an adult parent or guardian. Entra Health Systems will not knowingly collect or use any personal information from individuals under the age of eighteen without the consent of a parent or guardian, or provide any personally identifying information collected from children, regardless of its source, to any third party for any purpose.

If a visitor submits information to the web site through the registration process that indicates the visitor is a child, the child's parent or guardian will be alerted to the child's registration and will be provided instructions on how the parent or guardian can delete the child's registration, if so desired. Entra Health Systems does not require a child to disclose more information than is reasonably necessary to participate in an activity.
